2017-2018 Report (As of December 31, 2018)

The Montana Mental Health Trust ("the Trust") was created in November 30, 2012 to receive the assets of the Montana Mental Health Settlement Trust (the "Settlement Trust") subject to the monitoring and grant obligations of the specified grantees of the Settlement Trust.

The Trust is to make grants to organizations and individuals who provide education, crisis intervention, funding for persons transitioning from in-patent mental health treatment to out-patient treatment, children's mental health programs, peer-to-peer services, and other programs, services, and/or resources dedicated to the prevention, treatment, and management of mental illness of Montanans.

The Trust received \$5,640,439.10 from the Settlement Trust. The Trust also received \$2,255 in donations.

2017-2018 Trust Expenses and Income. The Trust received refunds of \$25.00 from Lewistown NAMI for unspent funds, \$166.20 from Gallatin County for unspent funds, and \$6,490.92, from the Montana Supreme Court for unspent funds. The Trust received \$234,580, from a settlement by the State of Montana with Squibb, and contributions \$25.00 from S. Senior, and \$50.00 from S. Pease. The total of trust expenses during 2017-2018, was \$586,610.33. They can be broken down as follows:
